If winners cannot be notified within five (5) days after notification attempt or if prize notification is returned as undeliverable, the applicable prize will be awarded to an alternate winner. The winner must complete & return an affidavit of eligibility and liability/publicity release within 14 days after date of notification, or an alternate winner will be selected.
